2. BROTHERS AND SONS

Nora Kaminski, the quick-witted physician without a doctor's title, who shares an apartment on the island of Rügen with her surgery colleague and good friend Richard, receives an unexpected visit from her son Kai. Her acquaintance with the Butenschön brothers raises a bit of dust in her everyday dealings: she just happens to be over the moon about handsome fisherman Matthias.



6. ANOTHER SHORE

Usually Nora is pretty good at multi-tasking, but at the moment the stress-resistant physician is pushing beyond her limits. She needs to take care of patients, keep the books and raise the money to buy the practice on Rügen outright – all by herself. She keeps regretting to have fired nurse Mandy. And searching for a new partner in the practice is harder than she thought. It seems like a match made in heaven then that Dr. Stresow, a genius from Switzerland, sends her an application.



3. THE LAWSUIT

When physician Nora Kaminski began her new job on the island of Rügen, she hoped to be able to leave her time as a ship's physician behind her. But now she is obliged to go to court in order to justify the death of a patient on board of her boat. The false testimony of a witness could not only cost her a lot of money in compensation, she could also be charged with manslaughter.



7. OLD FRIENDS

One year after the death of her friend and colleague Richard Freese Nora Kaminski has her "Practice with a view" back on track. Even getting into a collegial flow with her new partner Dr. Hannes Stresow has been accomplished. In her private life, Nora has been caught up in an old love affair: Her ex Peer Kaminski has not been drawn to the island merely for his newly acquired boat. Nora and Peer's already strained relationship does not get less complicated by this.
